Please indicate which item you would like to address on the speaker slip and, in your testimony, which portion of the project you will be addressing in your comments. Please be aware that the Commission will consider testimony on both the project and the related environmental document.

Hearing on the request of the State of California Department of Transportation (Caltrans) to consider the following:

- a) 19DVP-00000-00026 [application filed on April 17, 2019] for approval of a Development Plan in compliance with Section 35-174 of Article II, the Coastal Zoning Ordinance, on land zoned TC (Transportation Corridor), to improve approximately 4.5 miles of Highway 101 between P.M. (post miles) 4.6 and 9.2 by adding a part-time, continuous access HOV (High Occupancy Vehicle) lane in both the northbound and southbound directions within the highway corridor, and for related development including on/off ramp improvements, soundwalls, undercrossing improvements, freeway signage, bridge replacement, tree removal and replacement, landscaping and selected pedestrian, bicycle, and lighting improvements;
- **b) 19CDP-00000-00053** [application filed on April 18, 2019] for a Coastal Development Permit in compliance with Section 35-169 of Article II, the Coastal Zoning Ordinance on land zoned TC, for improvements described under 19DVP-00000-00026, above; and,

Caltrans is the designated lead agency under California Environmental Quality Act (CEQA) reporting requirements. Caltrans completed an Environmental Impact Report (EIR) on August 26, 2014, a revised EIR on October 27, 2017, and an EIR Addendum on June 1, 2018. As a result of this project, potentially significant and unmitigable (Class I) effects on the environment are anticipated for project-specific and cumulative Visual Resource impacts, and project-specific and cumulative Transportation/Circulation impacts. Potentially significant but mitigable (Class II) effects on the environment are anticipated in the following categories: Biological Resources, Cultural Resources, Noise, Paleontology, and Water Quality.
